### C. Key Principles of Assurance

<b>Principle 1:</b> We need to draw our assurance from faith in the facts of Scripture and <i>not from our</i>
<b>Principle 2:</b> We need to draw our assurance from faith in the facts of Scripture and <i>not from our</i>
* Does God want believers to base their assurance on their ability to live with proper Christian conduct?  Or, does God encourage proper Christian conduct on the basis of what God has already guaranteed? (1 Cor. 1:2, 3:1-3, 6:20, Eph. 4:32)
* What does the Bible teach that proper Christian conduct is evidence for? (1 John 1:6-7)

## D. The Common Objection

"Does the fact that we are confident of our salvation because of the finished work of Christ mean we can be indifferent about our lifestyle?

Does assurance of salvation promote promiscuous Christian living and faulty stewardship? No, not if one understands the whole counsel of the Word.
